



By signing this, you are giving First Aid Collision authorization to complete the repairs listed on this estimate, you are agreeing to pay your deductible and or any charges applicable to First Aid Collision at completion of repairs. You are giving First Aid Collision permission to operate your vehicle on streets, highways or elsewhere for road testing or moving to another facility for the purpose of repairs. You are also giving First Aid Collision permission to complete a diagnostic scan your vehicle. First aid collision is not responsible for any damages to vehicle or articles left inside vehicle caused by fire, theft, vandalism or other causes beyond our control. If you are getting into a rental, First Aid Collision WILL NOT be responsible for any charges you may incur while your vehicle is in our shop.

You understand that the estimate may change after full disassembly is completed. You understand that the estimated delivery date is not guaranteed and is subject to change. Old parts removed from the vehicle will be discarded unless otherwise instructed in writing at time of drop off. You understand that First Aid Collision's final invoice for repairs of your vehicle may not match that of the insurance company's estimate as to parts, labor or procedures used to repair your vehicle. You understand that parts prices are based upon recent estimating software and subject to change. You understand that repair techniques employed are based upon First Aid Collision's judgement as to the best practices resulting in a high-quality repair.

If your vehicle is deemed a total loss, you give First Aid Collision permission to release your vehicle to the insurance company and you are giving the insurance company permission to pay any fees associated with processing the total loss. All total loss vehicles will incur a 25% restocking fee on any parts ordered. You understand that if you decide to retain the vehicle, these fees may be your responsibility. If you decide to retain your total loss vehicle, FAC will NOT reassemble your vehicle and it will be your responsibility to have vehicle towed off the lot.

WE DO NOT ACCEPT PERSONAL CHECKS. You will be charged a 3% transaction fee for all credit card purchases over \$1000. You understand all repairs must be paid in full prior to vehicle release.

If you decide not to repair your vehicle after disassembly, You will be charged any teardown and administrative fees associated with processing your vehicle. You have 48 hours after receipt of this estimate to provide approval to move forward with repairs or have vehicle removed from our facility. If you decide to not have your vehicle repaired, you will have sign a waiver (Hold Harmless agreement) releasing us of any liability of safety before taking it off of our lot. After vehicle has been on site for 30 days and we have not received any communications of approval from you, we will start the process with DMV for vehicle abandonment. You agree that you will have your vehicle picked up within 1 business day of completion and understand that you are subject to a \$75 per day storage fee after 2 business days.

To speed repair times, First Aid may transfer vehicles from one center to another. Please initial here if you give First Aid permission to transfer your vehicle. Initials: _____
